WELSH RUGBY UNION CONSULTATION ON THE FUTURE OF WELSH PROFESSIONAL RUGBY

Further to minute 55 of the Town Council meeting held on the 3rd September 2025, the Town Council has written to the Welsh Rugby Union to express its full support for the retention of the Scarlets as a professional rugby team in whatever structure the WRU looks to implement at the end of the consultation being undertaken.

The Town Council has also contacted the Scarlets and supporter groups to express its support for the campaigns being undertaken on the matter.

Members will be aware that supporters are arranging a demonstration of the Community's support in the form of a march to Parc y Scarlets prior to the next home match against Munster on the 27th September 2025. The Town Council has contacted the organisers and the Scarlets management to look to discuss these arrangements and support that can appropriately be provided by the Town Council.

Suggestions have included:

- Arranging local choirs to attend Parc y Scarlets to take part in events around the match;
- Arranging provision of a shuttle bus for fans to be able to attend these events and the match itself.

Contact has therefore been made with local choirs to make them aware of this possibility, prior to formal arrangements being agreed on events surrounding the match.

Contact has also been made with local bus companies to seek options, with only First Choice being available, their price was £420 for provision of a 70 seater bus with £100 per journey for a shuttle service from the Town Centre to Parc y Scarlets.

Other possible arrangements will be discussed with the fans groups and the Scarlets Management and reported to members.

RECOMMENDATION – that the report is noted and

- the actions taken and proposed be approved, with Officers, the Council Leader and Opposition Leader authorised to take forward arrangements as necessary and appropriate;
